
MEMORANDUM OF ASSOCIATION

OF

ROTARY CLUB OF HALIFAX HARBOURSIDE



- 1. The name of the Society is Rotary Club of Halifax Harbourside.
- 2. The objects of the Society are:
 - a. To encourage and foster the ideals of Rotary International, namely, of service as a basis of worthy enterprise through the development of: acquaintance and fellowship as an opportunity for service, the promotion of high ethical standards in business and professions, the application of service in every member's personal, business and community life, and advancement of international understanding, goodwill and peace through a world fellowship of business and professional persons;
 - b. To the extent the laws of the Province of Nova Scotia and the laws of Canada applicable therein permit, the Society shall be subject to the jurisdiction of Rotary International;
 - c. To participate in Rotary International projects including the Ambassadorial Scholarship Program, Group Study Exchange, Matching Grants Programs and Polio Plus;
 - d. To undertake activities to raise funds for charitable purposes beneficial to the community as a whole, for the advancement of education and for the relief of poverty in Halifax Regional Municipality, Nova Scotia, Canada and the world both as the Society's own initiative and by providing funding and assistance in efforts in other organizations;
 - e. To engender fellowship and enthusiasm among the members of the Society for the aforesaid purposes;
 - f. To acquire by way of grant, gift, purchase bequest devise or otherwise real and personal property and to use and apply such property to the realization of the objects of the Society;
 - g. To buy, own, hold, lease, mortgage, sell and convey such real and personal property as may be necessary or desirable in the carrying out of the objects of the Society;

- h. To establish and supervise a Trust to carry out all or part of the charitable activities of the Society and to seek to obtain and maintain status as a registered charity with Revenue Canada.
- 3. The activities of the Society are to be carried on in the Halifax Regional Municipality, Province of Nova Scotia.
- 4. The registered office of the Society is situated at 208-5880 Spring Garden Road, Halifax, Nova Scotia, B3H 1Y1.

<u>PROVIDED</u> that nothing herein contained shall permit the Society to carry on any trade, industry, or business and the Society shall be carried on without purpose of gain to any of the members and that any surplus or any accretions of the Society shall be used solely for the purposes of the Society and the promotion of its objects.

<u>PROVIDED</u>, further, that if for any reason the operations of the Society are terminated or are wound up, or are dissolved and there remains, at that time, after satisfaction of all its debts and liabilities, any property whatsoever, the same shall be paid to some other charitable organization in Canada, having objects similar to those of the Society.

We, the several persons whose names, addresses and occupations are subscribed, desire to be formed into a Society, in pursuance of this Memorandum of Association.
